Race Rules

1. All swimmers must swim the prescribed course and ensure that their name is marked off the official Entrants register at the conclusion of the Swim even if they do not complete the course.
2. Swimmers must swim in the race category for which they are eligible.
3. All swimmers must wear their prescribed cap and race number.
4. A swimmer may use aids such as flippers, snorkels or flotation clothing or devices but such swimmers will not be eligible for any prize or qualify as an official placegetter.
5. Any swimmer accompanying an under 12 year aged swimmer will not be eligible for a prize or qualify as an official placegetter.
6. All swimmers are to behave in a fair and sportsmanlike manner without interference or aggression towards any other competitor and any breach of this rule may result in disqualification from the Swim.
7. If in the opinion of an appointed medical officer or a water safety officer a competitor is physically or otherwise incapable of starting or completing the Swim or has been in the water for an inordinate period of time such competitor may be disqualified from starting or be removed from the water at any time.
8. If in the opinion of the Club the weather or swimming conditions are dangerous or unsuitable the Swim may be cancelled without notice.

Warranties and Acknowledgements

By signing this entry form I warrant that I (where signed by the entrant) / that the entrant (where signed by the entrant and their parent / guardian; where the entrant is under 18 years of age):

1. Am / is physically fit and have / has trained sufficiently for the Swim and my / their physical condition has been verified by my/ their medical practitioner,
2. Consent/s to receive such medical treatment which may be deemed advisable by the Organisers, medical and first Aid assistants, beach or water safety personal in the event of injury, accident or illness during the Swim,
3. Assume/s full responsibility to inform myself / themselves and assess all the dangers hazards and risks before participating in the swim,
4. Permit/s free use by the organisers of my / their name and photograph in any broadcast, telecast or other media as may pertain to the Swim,
5. Have / has sole responsibility for my / their personal possessions and equipment during the Swim,
6. Acknowledge/s that in the event of cancellation of the Swim my / their entry fee shall not be refundable by the Club,
7. Acknowledge/s that the terms and conditions contained in this entry form shall be construed broadly to provide a release indemnity and waiver to the Organisers to the maximum extent permitted by law and shall be construed according to the law of New South Wales.

Release and Indemnity
